PADDLE BOATS RULES AND REGULATIONS

1. Paddle boats are available any time the pool is open unless Lake is closed due to maintenance issues. **Last check-out time is 1 hour before sundown or 1 hour before pool closes** (whichever is first).
2. Recreational Pass holder must be 18 years or older with current Recreational Pass in order to check out a paddle boat.
3. Children under 14 years old must wear life jackets. At least one adult needs to sit in the front seat and drive the paddle boats.
4. No children under 2 years old are allowed to ride in the paddle boats.
5. **Recreational Pass** holder must sign Paddle boat User Agreement and Rules and leave their **Recreational Pass** with the Pool Monitor while out on the paddle boats and must adhere to all Rules regarding paddle boats.
6. No alcoholic beverages, food or glass containers are allowed on the paddle boats.
7. People violating these Rules may be restricted from using paddle boats.

PADDLE BOAT USER AGREEMENT AND RULES

Resident must be 18 years of age with a current VGHOA **Recreational Pass** to check out a boat. **Recreational Pass** must be left with Pool Monitor while using paddle boat.

Maximum time for taking out a boat is 1 hour.

Four people maximum to a boat; 2 adults and 2 children. Children under 14 must wear a life jacket and sit in the back of the boat when there are 2 adults. Only 2 adults or 3 small adults at a time in a boat. **NO CHILDREN UNDER 2 YEARS OLD ARE ALLOWED IN BOAT. NO PETS ARE ALLOWED IN BOATS.**

Recreational Pass holders are liable for any damages to the boats. Minimum of \$25.00 for broken rudders.

Boats are available anytime the pool is open unless Lake is closed due to unforeseen events. **Last check-out time is 1 hour before sundown or 1 hour before closing (whichever comes first).**

Alcoholic beverages, food, and glass containers are **STRICTLY PROHIBITED.**

NO FISHING is allowed off the paddle boats. Do not feed the ducks or other water fowl.

ALL OTHER VGHOA RULES PERTAINING TO COMMON AREAS ARE STILL IN EFFECT AND MUST BE OBSERVED. VIOLATION OF THESE OR ANY OTHER VGHOA RULES COULD RESULT IN SUSPENSION OF PRIVILEGES AND/OR FINES TO COVER DAMAGES.
